Hence, this may be called Bio-Medical Waste Management (Amendment) Rules 2019.

**Terms of References:** The primary objectives of the Bio-medical Waste Committee include-

1. The committee prepares an **annual report** of the Biomedical waste management at SMCW & SUHRC.
2. The committee ensures information, education, and Communication (**IEC**) activity acts in SMCW & SUHRC.
3. The committee prepares and updates the **manual** of Biomedical waste management.
4. To ensure **statutory compliance** as per Maharashtra Pollution Control Board (MPCB).
5. To optimise treatment and disposal methods by efficient management practices, and providing cost-effective services to the hospitals.

**Meeting Frequency:** Quarterly in a year

**Quorum:** A quorum of 60% is necessary for the committee to meet, including the chairman, the member secretary, and other members. The members must assign their representative in case of their unavailability.

**Minutes of Meetings (MoM):** The Member Secretary is responsible for maintaining, and uploading the link of **Minutes of Meetings (MoM)**, and circulating the MoM in the approved format.

**Action Taken Report (ATR):** The member secretary will update, upload in the link of SMCW & SUHRC **Minutes of Meetings (MoM)**, and circulate the ATR before the commencement of the next meeting.
