
The Symbiosis International (Deemed to be University) has applied for establishment of Medical College at Gram: Lavale, Tal: Mulshi, Dist: Pune- 412 115. On careful consideration of proposal the Government of Maharashtra has decided to issue an Essentiality Certificate to the applicant for the establishment of the Medical College for Girls with 150 Seats.

It is certified that:-

a)	The applicant owns and manages 300 bedded Hospital which was established in 2019.
b)	It is desirable to establish a Medical College in the public interest;
c)	Establishment of a Medical College at Gram: Lavale, Tal: Mulshi, Dist: Pune by Symbiosis International (Deemed to be University) is feasible.
d)	Adequate clinical material as per the Medical Council of India norms is made available by the Institution.
e)	The Symbiosis International (Deemed to be University) own and possess 37.85 Acres land at Gram: Lavale, Tal: Mulshi, Dist: Pune on which non-agricultural use of land is permitted and a Medical College/Hospital can be established on it.
f)	The building plan of the Hospital and Medical College has been approved by the competent authority, namely, Pune Metropolitan Region Development Authority (PMRDA) and District Collector, Pune designated by the State Government for such purposes on 30.04.2012.
g)	The Hospital and Medical College have been granted completion certificate/building use certificate by the competent authority namely, Pune Metropolitan Region Development Authority (PMRDA) designated by the State Government for such purposes on 20.05.2019.

It is further certified that in case, the applicant fails to create infrastructure for the Medical college, as per MCI norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.

This Certificate is valid for a period of 3 year from academic year 2019-20 thereafter it will be automatically lapse.
